




## Reference Shot of Features (1 of 2)





## **Land Acknowledgement Statement**

We acknowledge the lands and waters now known as Maryland are the home of its first peoples: the Accohannock Indian Tribe, Assateague People's Tribe, Cedarville Band of Piscataway Indians, Choptico Band of Indians, Lenape Tribe, Nanticoke Tribe, Nause-Waiwash Band of Indians, Piscataway Conoy Tribe, Piscataway Indian Nation, Pocomoke Indian Nation, Susquehannock Indians, Youghiogheny River Band of Shawnee, and tribes in the Chesapeake watershed who have seemingly vanished since the coming of colonialism. We acknowledge that this land is now home to other tribal peoples living here in diaspora. We acknowledge the forced removal of many from the lands and waterways that nurtured them as kin. We acknowledge the degradation that continues to be wrought on the land and waters in pursuit of resources. 



### **MSAC Definition of Public Art**

"Art that is **created intentionally for a place** and space in the public realm, regardless of whether it is situated on public or private property. Located indoors or outdoors, **public art is free and accessible** to everyone.

Public art can include: expressions of community values or enhancements to an environment, and can raise awareness of an unseen narrative. Public art supported by MSAC grants must have a physical presence and a lasting impact on the place and community where it is installed."

## For this grant...

"Temporary" public artwork and installations are eligible for funding, but all artwork must have a <u>physical presence</u>, and be <u>installed for an intentional length of time</u>.

In all cases, the lead artist, partners/organizers, and property owner should have considered and agreed to the duration of time that the artwork is expected to remain installed; and who will be responsible for repairing or removing the work at the end of that period, or if the condition has deteriorated before the end of the agreed upon period.





Offers funding to support the planning, creation, and installation of new, original, local public art projects.

• Eligible applicants for the New Artworks Planning grants may be independent artists or organizations, as outlined in next slide.

Eligible applicants for New Artworks Project grants must be an organization, as outlined below.



#### Independent artists must be:

- An artist or collaborative group not directly affiliated with a larger arts organization or program
  - In the case of collaborative groups, having a membership comprising at least 50 percent Maryland residents, as defined below
  - In the case that an artist(s) is fiscally sponsored, the sponsored artist(s) must be a
     Maryland resident, as defined below
- Maryland residents (i.e., owning or renting residential property in Maryland six months before the application's submission and throughout the funded project or program) who are 18 or older; those experiencing homelessness are encouraged to reach out to MSAC staff for details on how to apply
- The lead artist whose original work is included in the proposed activities
- Not enrolled in any matriculated high school, undergraduate or graduate degree program at the time of application and throughout the grant activities outlined in the application.



#### Organizations or Art Programs must be one of the following:

- Nonprofit organization (i.e., an organization with an IRS-designated 501(c)3 status) based in Maryland
- Nonprofit, Maryland-based fiscal sponsor organization applying on behalf of a Maryland-based group, project, or artist(s) with whom it has a Model A fiscal sponsorship agreement in place (i.e., comprehensive sponsorship, in which the assets, liabilities, and exempt activities collectively referred to as "the project" are housed within the fiscal sponsor)
- Unit of government (e.g., town, city, county, state, etc., with the capacity to undertake an arts program)
- College or university (i.e., an established higher education institution in Maryland) School (i.e., a public or private school serving students in grades pre-kindergarten through 12)



Applicants may only submit one PAAM grant application per fiscal year.

Grantees receiving Project Grants (New Artworks and Conservation) in the prior fiscal year (FY24) are not eligible to apply for any PAAM Project Grant in the subsequent fiscal year (FY25).

#### **NEW ARTWORKS: ARTWORK ELIGIBILITY**

- The artworks must be considered public art as defined in the MSAC glossary-refer to glossary here
- The artwork must be designed by a Maryland artist, as well as be new, original, and specifically designed and fabricated for the Public Art Across Maryland program
- The artwork type may include, but not be limited to: sculpture, mural/painting, tile mosaic, mixed media, photography, and digital works. The artwork may also be functional amenities such as: benches, bike racks, creative way-finding, fences, screens, gateways, light works, awnings, and trellises.
- The artwork may be temporary or permanent but must be intended for the public realm, and may be sited in or on any interior or exterior space accessible to the public, such as: parks and trails, plazas, sidewalks, community centers, libraries, schools, and local government buildings



#### NEW ARTWORKS: ARTWORK ELIGIBILITY

- Publicly accessible
- In compliance with local jurisdiction's regulations, permissions, and permitting requirements for siting and installing artwork(s) on public or private property.
   Applicants are required to do their own research in this regard.
- Artworks installed on private property must describe how the site is significant to the community and is accessible to and benefits the greater public
- For Project grants: the artwork must have been developed through a community engagement process



#### **NEW ARTWORKS: PLANNING**

#### **Use of Funds:**

Used to support independent artists and/or organizations developing public art project ideas and proposals with communities. Grant funds may be used for:

- Administrative fees related to community engagement activities conducting a Call to Artists to select artist(s), garnering artwork permits/approvals, and determining who will oversee and fund maintenance
- Artist fees and/or honorariums for artwork proposal design and proposal development.
- Support for seeking and working with an organization partner
- **Consultant fee(s)** such as public art consultant, design services from architects or landscape architects, engineering services, digital graphics services, etc.
- Facility/equipment rentals for community meetings
- Online application software fees
- Artwork proposal design and development including services such as digital renderings, shop drawings design/engineering reviews, permit applications



#### **NEW ARTWORKS: PROJECT**

**Use of Funds:** To support organizations that are working with an artist(s) to fabricate and install new public artwork(s). The artist(s) creating the public art must be identified and the artwork must be fully designed and have proof of permission to be installed at the time of application. The project must have been developed through a community engagement process. Grant funds may be used for:

- Artist(s) fee(s)
- Contracted services such as studio assistants, fabricators, contractors, artwork installers, photographers, etc.
- Equipment and/or space rentals needed for fabrication and/or installation
- Artwork materials and/or tools for fabrication and/or installation
- Plaque/Interpretive signage
- Transportation of the artwork to the site
- **Insurance**, **permitting** fees
- Organization administration/project management fee (cannot exceed 10% of the total grant request)
- Artwork dedication expenses, including signage plaque







Eligible applicants for Planning and Project grants must be an organization, as outlined in next slide

#### Organizations or Art Programs must be one of the following:

- Nonprofit organization (i.e., an organization with an IRS-designated 501(c)3 status) based in Maryland
- Nonprofit, Maryland-based fiscal sponsor organization applying on behalf of a Maryland-based group, project, or artist(s) with whom it has a Model A fiscal sponsorship agreement in place (i.e., comprehensive sponsorship, in which the assets, liabilities, and exempt activities collectively referred to as "the project" are housed within the fiscal sponsor)
- Unit of government (e.g., town, city, county, state, etc., with the capacity to undertake an arts program)
- College or university (i.e., an established higher education institution in Maryland) School (i.e., a public or private school serving students in grades pre-kindergarten through 12)



#### **CONSERVATION: ELIGIBILITY**

Applicants may only submit one PAAM grant application per fiscal year.

Grantees receiving Project Grants (New Artworks and Conservation) in the prior fiscal year (FY24) are not eligible to apply for any PAAM Project Grant in the subsequent fiscal year (FY25).

- The final location of the artwork to be conserved must be in Maryland
- The artwork type may include, but not be limited to: sculpture, mural/painting, tile mosaic, mixed media, photography, and digital works. The artwork may also be functional amenities such as: benches, bike racks, creative way-finding, fences, screens, gateways, light works, awnings, and trellises
- Artwork must be publicly accessible

#### **CONSERVATION: ARTWORK ELIGIBILITY**

- Artwork must comply with the local jurisdiction's regulations, permissions, and permitting requirements for conserving artwork(s) on public or private property.
   Applicants are required to do their own research in this regard.
- Artworks installed on private property must describe how the site is significant to the community and is accessible to and benefits the greater public

The eligibility guidelines listed above provide an overview only. There may be instances where MSAC staff make eligibility determinations based on situations not described here but in support of the mission of the agency and the Department of Commerce.



#### **CONSERVATION: PLANNING**

**Use of Funds:** to support conservation planning efforts for the proposed public artwork located in Maryland. Grants may be used for:

- Administrative fees related to project management and planning
- Consultant fee(s) such as:
  - Professional Conservator
  - Artist
  - Structural Engineer
  - Materials specialist (painter, welder, etc.)
  - Historian
  - Preservationist

#### CONSERVATION: PLANNING

**Use of Funds:** to support conservation planning efforts for the proposed public artwork located in Maryland. Grants may be used for:

- Community Engagement includes:
  - Public meetings
  - Community Education
  - Information campaigns
- Collection Management Activities & Technology including: Collection Management consultant, Local survey or inventory work, Inventory file digitization, Creation or update of an artwork database, Purchase or lease of collection management software



#### CONSERVATION: PROJECT

**Use of Funds:** may be used to support the execution of a fully developed and planned conservation work on the proposed public artwork located in Maryland. Grant funds may be used for:

- Relocating a public artwork within or to Maryland to increase public access to the artwork and its long-term preservation. It is intended the artwork be conserved as part of this process.
- Conservation and maintenance activities that will contribute to the long-term appreciation and sustainability of the artwork including but not limited to:
  - Cleaning, waxing, coating, and painting conducted by professional service providers
  - Replacement or addition of components to provide structural integrity to the artwork, frame, plinth, pedestal, base, or foundation integral to the display of the artwork



#### CONSERVATION: PROJECT

**Use of Funds:** may be used to support the execution of a fully developed and planned conservation work on the proposed public artwork located in Maryland. Grant funds may be used for:

- Landscape site improvements such as drainage, plant pruning, maintenance, and/or replacement
- **Lighting and electrical work** that contributes to public accessibility by increasing visibility and safety, or improves energy efficiency of outdated lighting and digital components
- Conservation of existing or the creation of new identification and interpretive signage, including writers, designers, fabrication, and installation
- Organization administration/project management fee (cannot exceed 10% of the grant request)

- 3. Provide a roster with the names of the conservation team members and a brief narrative of relevant education and experience.
- 4. Conservation Project Schedule
- 5. Conservation Project Budget



#### CONSERVATION: PROJECT APPLICATION

#### Attachments (see page 10):

- 1. A map of the artwork location (can be a Google Map)
- 2. Upload one (1) PDF file with the following: Photos of the artwork to be conserved, close-ups of critical area Include plans, if applicable
- 3. Letter(s) of Permission

#### **Grant Review Process**

#### The Review Panel

- Prospective panelists apply through an Open Call
- MSAC selects 10 -13 panelists with grant and public a experience from across Maryland



MSAC Public Art staff do NOT score applications

#### **Grant Review Process**



#### **Round 1**

- Panelists review and provide initial scores for applications independently on-their-own & provide written comments on each grant question.
- Scores from all panelists are averaged for each application
- High scoring applications that meet the % threshold are advanced to Round 2





#### **Grant Review Process**



#### **Round 2**

- Virtual panelist meeting, they discuss and submit final scores for Round 2 applicants
- Scores from all panelists are averaged for each application
- The meeting is open to the public;
- Applicants and guests may observe but must remain on mute and off camera for the duration of the meeting.
- Final awards are determined by MSAC staff following the meeting.

If your application advances to Round 2, you will be notified.

#### **GRANT SCHEDULE**

- 1. **Grant status notification is March 2025**. Then you can start the project activities that are supported by MSAC.
- 2. Awardees will be sent a Grant Agreement Form in SmartSimple. You might sign and submit the Form to start the grant processing stage.
- 3. Approx. 8 weeks from signing your Grant Agreement Form you'll receive the check, likely in May. Plan your activities, material purchases, artist fees... accordingly.

It is ok to begin grant activities immediately after notification. (Some awardees may be able to 'front' the money to start the project before the check arrives, and then reimburse themselves or organization when the check is received)
