Call to Order



Commission Chair, Kathy O'Dell called the meeting to oder at 9:00 am and reviewed the guiding documents.

Approval of Prior Meeting Minutes

Elaine Bachmann moved to approved the March 2024 minutes. Rebecca Massie Lane seconded the motion. The approval passed unanimously.

MSAC Executive Director Report

Steven Skerritt-Davis, MSAC Executive Director provided an update to the Commisison.

- MSAC Staffing Update
- FY24 Updates: \$732,282: Public Art Grant Funding, 36 projects in 18 countries
- FY25: \$36, 406,766 budgets (includes capital program) \$725,00 = Public Art Across Maryland Grants. Due to demand there are some recommended policy changes currently under review that would limit an organziations ability to apply for more than one application per funding cycle, or be eligible to receive a project grant if they were awarded a project grant in the prior year. One application/applicant/year.
- Line items: The Council will be discussion policies to address line items in the state budget.

Discussion:

Elizabeth:

- Projects Grants: Are they one and done? our grants are phased.
 - Answer: Liesel: they are one and done, they can get the grant and it should be able to finish the project within the grant
- Line Item Grants: When did you find out about the line item requests?
 - Steven: As committees were working on the budget we found out about the line item requests
- Rebecca: What types of examples come in?
 - Steven: \$400,000 general operating support, through MSAC they receive \$100,00. The BSO - they receive \$905,000- stabilization grant funding and \$500,000 to support their tour around the support. We also support their operating at \$1,000,000 through MSAC
- Kathy: Clarify: Planning grant recipients can also apply for project grant the following year?
 - Answer: Correct
- Kathy: What are the following next steps post Liesel's departure?
 - Answer: We will retain the Director and project manager role. We will inform the commission when more details are

 - Elizabeth: Who is responsible for maintaining the inventory:
 - Liesel: The agency that owns



- Elizabeth: Do they have any requirements of how the agency maintains the artwork
- Ryan: A former MSAC staff Cindy Kelly did a lot of work around the state collection. Several works around the state. Institutional memory turns over - people forget who owns it. PArt of our role - keep the memory alive, specifically for the artwork, taking assessment of the artwork, conservation reports of the artworks that we commissioned and the pieces forthcoming. We communicate it is the responsibility of the institution.
- Judy: In Austin I worked with the public art commission. It doesn help to have a centralized stakeholder in charge of making sure that conditions are assessed. Have a central repository - database, map of artwork, inventory of the work. It's a comprehensive assessment statewide. Even though the fiscal responsibility may be elsewhere, have a central place of the collection management would be necessary.
- Chris: Is their an active inventory collect as institutional memory may fade away. Who reports to whom so when staff changes etc.
- Ryan: We do not have that process for that in place. IT's time to start that process.
- Kathy: ARe there other states that could serve as a model?
 - Yes
- Judy: I love that his is happening
- Kathy: Signage! "Why are there not signs!" Why don't we know who the artist is? Who owns the piece?

The State House Trust: Approved a project of Steven X Lee to have a memorial on the grounds of the State House to honor Black people who served in the Revolutionary War

- \$250,000 approve for the beginning of the project
- Project is now on it's way
- Commission of artistic property + MSAC + DSG are co-leading
- The memorial will be figurative but open to artist property
- Elaine: Thank you to Nora, Liesel and RYan for working with us on this
- It's going to be an Artists Call. We do not often have funds to commission art
- So we are doing a Request for Qualifications awaiting for final revisions
- August: Artist Call out, the Monument ADvisory Committee Appointed
 - State house trust

 - The Monument Advisory Committee: will advise the process
- Summer of 2026 it will be unveiled

Kathy: To keep on the mind of the Commission: Reactions within communities during Lock down and death of George Flloyd



- In Catonsville students at elementary creative response, the students could go outside, congregate at the school, chalk drawings, a beautiful mural in progress at all times at the school.
 - Discussion within the community (mostly positive and encouraging)
 - There was an off-duty police officer who taunted the students
 - Principal at the school to create safety by having it all power washed
 - Principal: took photos of the mural
- Wondering if there is a place for Commission to store photos of temporary works, in particular around equity
- Ways to manifest commitment to equity and justice through public art ways to support taht through the commission as time goes.
- Elaine B: spontaneous public art preservation The memorial at the Key Bridge
 - - How to preserve information, gathering the news and media
 - Creation of spontaneous art could have impact of the future bridge as far as its naming, food for thought
 - What role should we be playing spontaneously art
- Kathy: Lots to discuss and consider
- Jermine: I attended a zoom meeting w/ institutions spit balling how to preserve info about the key bridge. The focus was:
 - To create narratives about the people involved
 - There wasn't discussion around the physical objects 0
 - Baltimore Museums of Industry: Where can we get steal?
